MEMBER RULES AND CONDITIONS

1. Membership in the Collective is open to any person who meets all of the requirements of membership set forth herein without regard to that person's age, sex, race, nationality, political opinion, sexual preference, handicap, or marital status.
2. Membership in the Collective is restricted to "Qualified Patients" and their "Primary Caregivers," as those terms are defined by the *CUA*, the *MMPA*, the *AG Guidelines* and relevant case law.
3. No person shall be granted membership in the Collective until such time as the Governing Body, or its designees, verify that the applicant meets the following four (4) qualifications: [____]
 - a. The person is a California resident with valid California ID, driver's license, or other California or Federally issued photo identification;
 - b. The person has a written recommendation from a California licensed physician that is in good standing stating that the person has been diagnosed with a qualifying medical condition and is authorized to use medical cannabis, or a recommendation to act as a "Primary Caregiver" for a "Qualified Patient," which recommendation has been verified by the Collective to be valid and in effect;
 - c. No person under age 18 will be admitted to membership (except in extraordinary circumstances and only with the written consent of a parent or guardian, and then will only be provided medical marijuana in the form of edibles or other non-smoking consumables such as oils), although even persons 18 years of age may be denied membership at the discretion of Collective management; and
 - d. Agrees in writing to these Rules and Conditions and signs and initials the Member Pledge, including the promise not to distribute or divert marijuana to non-members and not to use the marijuana for other than medical purposes.

4. Each member is expected to make a contribution to the Collective to help insure realization of its purposes, its continuity and its sustenance. Contributions from members may vary based on the needs of the Collective and other variables such as the time and limitations of the various members, and may be financial only.ⁱ
5. The use of any non-organic pesticides or other harmful products in any medicinal product manufactured or cultivated for the Collective or its members is prohibited.
6. The re-sale or diversion for recreational purposes of any cannabis product obtained from the Collective is prohibited.
7. Obtaining medical marijuana or medical marijuana products inconsistent with member personal medical needs is prohibited.
8. Harassment, in any form, of Collective personnel or anyone in the vicinity of the Collective is prohibited.
9. Cultivation and/or Processing of Medical Marijuana Products by any person that is not a member of the Collective is prohibited.
10. Distributing and/or sharing medical marijuana products obtained from the Collective is prohibited.
11. Smoking or consuming any marijuana or related products on the Collective's premises or in the immediate vicinity of the Collective's premises, or in or around any vehicle used by the Collective to deliver medicinal marijuana to the Collective's patient members is prohibited.
12. Possession of Firearms, with or without a concealed weapons permit, on the Collective's premises or in the immediate vicinity of the Collective's premises, or in or around any vehicle used by the Collective to deliver medicinal marijuana to the Collective's patient members is prohibited.
13. Driving under the influence or operating machinery under the influence of medical cannabis obtained from the Collective is prohibited.
14. Engaging in any action or conduct that endangers the legal defenses and immunities of the Collective and its' members is prohibited.
15. Membership will be terminated if it is discovered that a member is not in compliance with any condition for membership.
